WHEREAS, the Louisiana Gaming Control Board has sent a Notice of Recommendation of Administrative Action to Licensee, which Notice contains allegations of certain violations of Liuisiana Gaming Control Luvy, and

WHEREAS, the issues carsed by said Notice were set for hearing before the Louisiana Gaining Control Board Administrative Hearing Office on May 22, 2024.

WHEREAS, the Division and I feetisee are destrous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice.

NOW, THEREFORF, in consideration of the foregoing, the parties hereto do hereby agree and supulate as follows

STIPULATIONS

- Licensee is a Type 2 freensed establishment focated at 3219 Fulanc Avenue Suite 201. New Orleans, LA 70119.
- 2. On March 15, 2023, the Division emailed a Video Gauting Advisory Notice to Literace informing them of the requirement to submit the annual fee and furnis no later than July 1, 2023.
- On November 30, 2013, the Division received the required annual tenewal forms and fee
- Licensee lailed to finish submit the required annual fee and supporting documents in violation of La. R.S. 27 405(K)(4)(a) and LAC 42.X(2405(B)(4)).

TERMS AND CONDITIONS

- In their of administrative action, Circhice will pay a penalty of SEVEN HUNDRED and FIFTY 00/100 (\$750.00) DOLLARS for its violation of the RS (27/435(K)(4)(a) and (d) and UAC 42/X1/2405(f)(4).
- The Division hereby agrees that payment of a total penalty of SEVEN III. SIDIRED and FIFT's 00/100 (\$750.00) DOLLARS shall be in full and final settlement of all nations set forth in the Notice of Recommendation of Administrative Action
- The Division reserves the right to take it to consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessment of Licensee's statability
- 4 The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Licensee, peraining to the subject matter contained berein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Consisting Gaining Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but with he submitted

to the Louisians Gaming Control Board for its determination as in whether to approve same or to remaind the matter to the Hearing Officer for a full hearing on the merits.

If approved, I receive agrees in make lift payment of the civil penalty within fifteen (15) days of approval of this sentenced by the Louisiania.
