**COMPROMISE AND SETTLEMENT AGREEMENT**

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter sometimes referred to as the "Division") and Hon. Gerald H. Schiff, Chapter 11 Trustee on behalf of and for Houma-Coteau Holdings, LLC d/b/a Houma-Coteau Travel Plaza, I-220 Travel Plaza, LLC d/b/a Goldmine Casino, Flying J Gaming, LLC d/b/a Flying J Gaming, Coushatta Truck Stop, LLC d/b/a Coushatta Truck Stop, H & R Truck Stop & Casino d/b/a Goldmine Casino, Caddo-Bossier Gaming Co., LLC d/b/a Caddo-Bossier Gaming Co., Harold L. **WHEREAS**, the Louisiana Gaming Control Board has issued Notices of Recommendation of Administrative Action ("Notice") to Licensees alleging certain violations of Louisiana Gaming Control Law; and

**WHEREAS**, the issues raised by the said Notices are set for hearing on December 22, 2010, before the Louisiana Gaming Control Board Administrative Hearing Office; and

**WHEREAS**, the Division and Licensees are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notices of Recommendation of Administrative Action;

**NOW, THEREFORE**, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

**STIPULATIONS**

1. Houma-Coteau Holdings, LLC d/b/a Houma-Coteau Travel Plaza, I-220 Travel Plaza, LLC d/b/a Goldmine Casino, Flying J Gaming, LLC d/b/a Flying J Gaming, Coushatta Truck Stop, LLC d/b/a Coushatta Truck Stop, H & R Truck Stop & Casino d/b/a Goldmine Casino, Caddo-Bossier Gaming Co., LLC d/b/a Caddo-Bossier Gaming Co., Harold L. Rosbottom, Jr. d/b/a Gaming Solutions, Big Top Travel Center & Casino, LLC d/b/a Big Top Travel Center & Casino, Nitro Gaming, Inc. d/b/a Mansfield Travel Plaza & Casino, Minden Truck Center, LLC d/b/a Trucker's Paradise, Pizza Town Café, LLC d/b/a Pizza Town Café, Nitro Gaming, Inc. d/b/a Nitro Gaming, Minden Truck Center, LLC d/b/a Waverly Truck Stop, Louisiana Gaming Corporation, St. Francisville Investments, LLC d/b/a Southern Belle Truck Stop & Casino, and Opelousas 190 Truckstop, LLC d/b/a Opelousas 190 Truckstop admit to the following violations:

- i. Failing to notify the Division of a Louisiana Department of Insurance investigation of member/owner Harold L. Rosbottom, Jr., in violation of LAC 42:XI.2417(B)(4 & 5);
  - ii. Failing to notify the Division of a settlement that was entered into between Harold L. Rosbottom, Jr. and the Louisiana Department of Insurance, in violation of LAC 42:XI.2417(B)(4 & 5); and

iii. Submitting an Annual Licensee Form to the Division without disclosing the Louisiana Department of Insurance investigation and settlement, in violation of LAC 42:XI.2405(A)(15).

2. Caddo-Bossier Gaming Co., LLC d/b/a Caddo-Bossier Gaming Co, Big Top Travel Center & Casino, LLC d/b/a Big Top Travel Center & Casino, I-220 Travel Plaza, LLC d/b/a Goldmine Casino and Minden Truck Center, LLC d/b/a Waverly Truck Stop further admit to submitting a Renewal Affidavit/Certifications to the Division without disclosing the Louisiana Department of Insurance investigation, in violation of LAC 42:XI.2405(A)(15).

#### TERMS AND CONDITIONS

1. In lieu of administration action, the Licensees will pay a civil penalty of THIRTY SIX THOUSAND DOLLARS and No/100 (\$36,000.00) for violating LAC 42:XI.2405(A)(15) and LAC 42:XI.2417(B)(4 & 5).

2. The Division hereby agrees to accept the Licensees' payment of the above stated penalty in lieu of administrative action in full and final settlement of the Notices of Administrative Action issued on November 10, 2010.


3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty, and in connection with any future assessment of the Licensees and Harold L. Rosbottom, Jr.'s suitability.

4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the state of Louisiana.

5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Licensees regarding the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve the same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement shall result in the immediate suspension of Houma-Coteau Holdings, LLC d/b/a Houma-Coteau Travel Plaza, I-220 Travel Plaza, LLC d/b/a Goldmine Casino, Flying J Gaming, LLC d/b/a Flying J Gaming, Coushatta Truck Stop, LLC d/b/a Coushatta Truck Stop, H & R Truck Stop & Casino d/b/a Goldmine Casino, Caddo-Bossier Gaming Co., LLC d/b/a Caddo-Bossier Gaming Co., Harold L. 
**ORDER**

**BE IT REMEMBERED** that on this the 22<sup>nd</sup> day of December, 2010, came on for consideration the Joint Motion for Approval of Compromise and Settlement Agreement, and the Hearing Officer having considered the pleadings on file, the proposed Settlement Agreement, and the said Motion, and it appearing to the Hearing Officer that the said Compromise and Settlement Agreement should be approved; it is, therefore,

**ORDERED, ADJUDGED, AND DECREED** that the Compromise and Settlement Agreement attached to the parties' Joint Motion for Approval of Compromise and Settlement Agreement be, and the same is hereby, **APPROVED**; that the Licensees must pay THIRTY SIX THOUSAND DOLLARS and No/100 (\$36,000.00) to the Division within fifteen (15) days of the approval by the Louisiana Gaming Control Board. Failure to do so shall result in the immediate suspension of the licenses of Houma-Coteau Holdings, LLC d/b/a Houma-Coteau Travel Plaza, I-220 Travel Plaza, LLC d/b/a Goldmine Casino, Flying J Gaming, LLC d/b/a Flying J Gaming, Coushatta Truck Stop, LLC d/b/a Coushatta Truck Stop, H & R Truck Stop & Casino d/b/a Goldmine Casino, Caddo-Bossier Gaming Co., LLC d/b/a Caddo-Bossier Gaming Co., Harold L. Rosbottom, Jr. d/b/a Gaming Solutions, Big Top Travel Center & Casino, LLC d/b/a Big Top Travel Center & Casino, Nitro Gaming, Inc. d/b/a Mansfield Travel Plaza & Casino, Minden Truck Center, LLC d/b/a Trucker's Paradise, Pizza Town Café, LLC d/b/a Pizza Town Café, Nitro Gaming, Inc. d/b/a Nitro Gaming, Minden Truck Center, LLC d/b/a Waverly Truck Stop, Louisiana Gaming Corporation, St. Francisville Investments, LLC d/b/a Southern Belle Truck Stop

& Casino, and Opelousas 190 Truckstop, LLC d/b/a Opelousas 190 Truckstop without the necessity of any further administrative action, until such time as the penalty is paid in full.


