COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Leslie M. Rosato (hereinafter, the "Permittee"), do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board sent a Notice of Recommendation of Administrative Action to the Permittee, which Notice contains allegations of certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notice are set for hearing before the Louisiana

Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and the Permittee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice.

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

 The Permittee holds a Non-Key Gaming Employee Permit approved by the Division.

- 2. On or about July 29, 2019, the Louisiana Gaming Control Board issued a Notice of Recommendation of Administrative Action against the Permittee's Non-Key Gaming Employee Permit, based on the Permittee's failure to report her arrest for violating La. R.S. 14:98, Operating a vehicle while intoxicated and La. R.S. 32:232, Traffic-control signals.
- 3. Per the provisions of LAC 42:III.2901(B)(4)(a) and (c), the Permittee has a continuing duty to notify the Division of an arrest within 15 calendar days of such arrest.
 - 4. The Permittee failed to timely notify the Division of her arrest.

TERMS AND CONDITIONS

- 1. In lieu of administrative action, the Permittee will pay a penalty of TWO HUNDRED FIFTY and 00/100 (\$250.00) DOLLARS for violation of LAC 42:III.2901(B)(4)(a) and (c).
- The Division hereby agrees that payment of a total penalty of TWO
 HUNDRED FIFTY and 00/100 (\$250.00) DOLLARS shall be in full and final settlement of all matters set forth in the Notice of Recommendation of Administrative Action.
- 3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation, or assessment of penalty and in connection with any future assessments of the Permittee's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- This Compromise and Settlement Agreement constitutes the entire agreement between the Division and the Permittee, pertaining to the subject matter contained herein and

supersedes all prior and contemporaneous agreements, representations, and understandings of the parties.

This Compromise and Settlement Agreement is subject to approval by the 6. Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

7. If approved, the Permittee agrees to make full payment of the civil penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board. The Permittee agrees that failure to meet this requirement shall result in immediate suspension of the gaming permit without the necessity of any further administrative action until such time as the penalty is paid in full.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.
