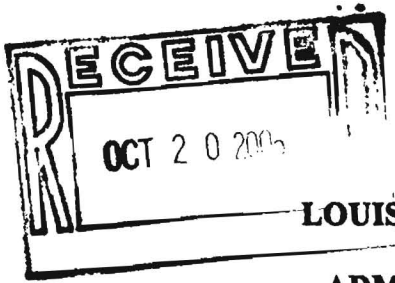

JOINT MOTION FOR APPROVAL OF PROPOSED SETTLEMENT

On Joint Motion of:

- (i) the State of Louisiana, Office of State Police, ("Division"), and
- (ii) Harrahs Bossier City Investment Company, L.L.C. d/b/a Harrahs Louisiana Downs ("Harrahs Louisiana Downs"),

who hereby propose the following settlement:

- (1) Harrah's does admit to violations of L.A.C. 42:VI.2715 (A)(7) and L.A.C. 42:VI.2325(C)(3).
- (2) Harrah's will pay a civil penalty of Twenty Thousand Dollars (\$20,000.00).
- (3) The Division hereby agrees to accept the Harrahs Louisiana Downs' payment of the above stated penalty in full and final settlement of this matter.
- (4) The Division reserves the right to take into consideration these violations in connection with any future violation.
- (5) This Stipulation and Settlement is to be interpreted under the laws of the State of Louisiana.
- (6) This Stipulation and Settlement constitute the entire agreement between the Division and Harrahs Louisiana Downs pertaining to the subject matter




contained, herein, and supercedes all prior and contemporaneous agreements, representations, and understandings of the parties.

- (7) This Stipulation and Settlement is subject to approval by the Hearing Officer of the Louisiana Gaming Control Board. It is expressly understood that if these proposed Stipulations and Settlement are approved by the Hearing Officer, this agreement is not executory and will be submitted to the Louisiana Gaming Control Board for its determination as to whether the matter should be heard by the Hearing Officer ; if approved, payment of the above penalty must be submitted within fifteen (15) days of this approval to the Louisiana Gaming Control Board
- (8) The Division and Harrahs Louisiana Downs waive their rights to appeal this Stipulation and Settlement if the Order is signed by the Hearing Officer and accepted by the Louisiana Gaming Control Board.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED, that Harrahs Bossier City Investment Company, L.L.C. d/b/a Harrahs Louisiana Downs shall pay as a civil penalty to the State of Louisiana the sum of Twenty Thousand Dollars (\$20,000.00) within fifteen days of approval of this settlement by the Louisiana Gaming Control Board.
