Keil (hereinafter "Keil"), and Bobby L. The Division and VendingData, Keil and Smith are desirous of compromising and settling all disputes between them relative to the referenced administrative proceeding. #### COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and VendingData Corporation (hereinafter "VendingData"), Ronald O. Keil (hereinafter "Keil"), and Bobby L. Smith (hereinafter "Smith") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Revocation to VendingData dated May 12, 2005 relative to VendingData's Non-Gaming Supplier Permit, Number P086501817 alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the Louisiana Gaming Control Board has issued Notices of Recommendation of Finding of Unsuitability to Keil and Smith dated May 12, 2005 alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the Louisiana Gaming Control Board has issued an Amended

Notice of Recommendation of Revocation to VendingData dated May 24, 2005 relative
to VendingData's Manufacturer of Gaming Equipment other than Slot Machines and

Video Draw Poker Devices Permit, Number P066502143 and Non-Gaming Supplier

Permit, Number P086501817 alleging certain violations of Louisiana Gaming Control

Law; and

WHEREAS, the issues raised by the said Amended Notice of Recommendation of Revocation to VendingData and the Notices of Recommendation of Finding of Unsuitability to Keil and Smith are set for hearing on January 24, 2006, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and VendingData, Keil and Smith are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Amended Notice of Recommendation of Revocation to VendingData and the Notices of Recommendation of Finding of Unsuitability to Keil and Smith.

NOW THEREFORE, in consideration of the foregoing, the Division and VendingData, Keil and Smith hereby propose to settle this matter pursuant to the following terms and conditions:

- 1. Immediately upon approval of this agreement by the Louisiana Gaming
  Control Board Hearing Office and Louisiana Gaming Control Board, VendingData shall
  voluntarily surrender its Manufacturer of Gaming Equipment other than Slot Machines
  and Video Draw Poker Devices Permit, Number P066502143 and Non-Gaming Supplier
  Permit, Number P086501817 to the Division.
- 2. Neither VendingData, Keil nor Smith will be eligible to hold, to be granted or to re-apply for, any approval authorized by the Louisiana Gaming Control Law for a period of thirty (30) months from the of the surrender of VendingData's permit.

- 3. From the date of the surrender of VendingData's permit, VendingData is prohibited from distributing or servicing, directly or indirectly, any of its products in Louisiana including gaming and non gaming supplies.
- 4. Vending Data will pay FIFTY THOUSAND DOLLARS (\$50,000.00) to the State of Louisiana within fifteen (15) days of the approval of this agreement by the Louisiana Gaming Control Board.
- 5. The Division hereby agrees to accept VendingData's, Keil's and Smith's compliance with and performance of these terms and conditions in full and final settlement of Amended Notice of Recommendation of Revocation to VendingData and the Notices of Recommendation of Finding of Unsuitability to Keil and Smith.
- 6. Any and all information discovered throughout the course of the VendingData, Keil or Smith investigations may be used in future investigations to determine the suitability of VendingData, Keil or Smith, as well as any natural or juridical person with whom any of them are or become, directly or indirectly, affiliated.
- 7. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 8. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and VendingData, Keil or Smith, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 9. This Compromise and Settlement Agreement shall be of no force or effect unless and until it is approved by both the Administrative Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed
