- 2 Ms. Berry has moved that we waive
- 3 that reading and approve those minutes, and
- 4 Mr. Poole has seconded that motion. Is there any
- 5 opposition to that motion?
- 6 (NO RESPONSE)

7 CHAIRMAN JOHNS:

- 8 Hearing none, that motion carries.
- 9 IV. REVENUE REPORTS

10 CHAIRMAN JOHNS:

11 Okay. Let's move into revenue

12 reports. Ms. Jackson? Always the highlight of my

13 meeting. I always want to see what those numbers

14 look like. So good morning.

15 MS. JACKSON:

16 Good morning, Chairman Johns and

17 Board Members. My name is Donna Jackson with

18 Louisiana State Police, Gaming Audit Section.

19 In May, the 13 operating riverboats

20 generated adjusted gross receipts of \$156,966,489.

21 The State collected fees totaling \$33,747,794.

22 Adjusted gross receipts for fiscal year 2022 to

23 date are approximately \$1.66 billion, an increase

24 of \$202 million, or 14 percent, from fiscal year

25 2021. As of May 31, 2022, the State collected

#### 14

1 \$356 million in fees for fiscal year 2022.

2 Page 2 shows the riverboat revenue

3 broken down by regional market. The overall

4 decrease from April was approximately \$4 million,

5 or 2.5 percent. Compared to last May, this

6 month's revenues represent a decrease of

7 \$11 million, or 6.6 percent.

8 Next is a summary of the May 2020 --

9 2022 gaming activity for Harrah's New Orleans,

- 10 found on page 3. Harrah's generated \$20,754,352
- 11 in gross gaming revenue. These revenues represent
- 12 a decrease from last month of \$6.2 million, or
- 13 23 percent, and a decrease of approximately
- 14 \$6 million, or 22.4 percent, from the same month
- 15 last year. During May, the State received
- 16 \$5,520,548 in minimum daily payments.
- 17 Adjusted gross receipts for fiscal
- 18 year 2022 to date are \$207.3 million, an increase
- 19 of \$18.7 million, or 10 percent, from fiscal year
- 20 2021. As of May 31, 2022, the State collected
- 21 almost \$56 million in fees for fiscal year 2022.
- 22 Next, I will present the revenues for
- 23 slots at the racetracks. During May, the four
- 24 racetracks facilities combined generated adjusted
- 25 gross receipts of \$29,577,048, a decrease of

- 1 \$1.2 million, or 3.9 percent, from April and a
- 2 decrease of \$3.7 million, or 11 percent, when
- 3 compared to the same month last year. During May,
- 4 the State collected \$4.5 million in fees.
- 5 Adjusted gross receipts for fiscal
- 6 year 2022 to date are \$302.8 million, an increase
- 7 of \$12 million, or 4 percent, from fiscal year
- 8 2021. As of May 31, 2022, the State has collected
- 9 almost \$46 million in fees for fiscal year 2022.
- 10 I will now move to the video gaming
- 11 information. There are 12,127 video gaming
- 12 devices activated at 1,432 locations. Net device

- 13 revenue for May 2022 was \$69,423,553, a decrease
- 14 of \$4 million, or 5.5 percent, when compared to
- 15 April and a decrease of \$8 million, or
- 16 10.6 percent, when compared to last May. Total
- 17 franchise fees for May 2022 totaled approximately
- 18 \$21 million, a decrease of \$1.2 million when
- 19 compared to April 2022 and a decrease of
- 20 \$2.6 million when compared to May 2021.
- 21 Net device revenue for fiscal year
- 22 2022 to date is \$764.4 million, an increase of
- 23 \$70 million, or 10 percent, when compared to
- 24 fiscal year 2021. Total franchise fees collected
- 25 for fiscal year 2022 to date are \$231 million, an

1 increase of \$20 million, or 9.4 percent, when

- 2 compared to last fiscal year.
- 3 Next, I will present the May revenue
- 4 for sportsbook. Fair Grounds commenced operations
- 5 on May 26, which brings the total retail
- 6 sportsbooks in operation to 16. During May, the
- 7 retail sportsbooks accepted approximately
- 8 \$28.5 million in sports wagers, resulting in net
- 9 proceeds of \$2.7 million and \$268,209 in State
- 10 taxes. The seven mobile sportsbook operators
- 11 accepted \$142.6 million in sports wagers,
- 12 resulting in net proceeds of \$22.6 million and
- 13 \$2.5 million in taxes paid to the State.
- 14 Finally, for daily -- daily fantasy
- 15 sports, gross revenues for May were \$901,000, with

16 a net revenue of approximately \$93,000 and taxes

17 of \$7,436. Are there any questions?

18 CHAIRMAN JOHNS:

19 Okay. Members, any questions for

- 20 Ms. Jackson? Any questions from the board?
- 21 (NO RESPONSE)

22 CHAIRMAN JOHNS:

23 Okay. Just a couple of observations

24 I would like to make. I have visited with a

25 number of the operators around the state in the

#### 17

1 last couple of weeks by phone, and, you know,

2 there's some concern about what's going on with

3 the economy, the price of gasoline, people

4 traveling, the inflation rates, the high interest

5 rates. And so there is some concern, and I think

6 some of these numbers are starting to reflect some

7 of those concerns. So something that -- not that

8 we can do a whole lot about it, but something that

9 we're going to watch, and -- and we'll keep, you

10 know, a very close eye on those numbers.

11 I did find it interesting on the --

12 on the sportsbook numbers, particularly on -- on

13 mobile in May, we did about \$44 million less in

14 actual wagers written from the beginning of this

15 month, but the win ratio was up significantly,

16 1.8 percent in April, 15.9 percent in May. So,

17 consequently, while -- even though 44 million less

18 in wagering occurred, almost \$1 million more in --

19 no. Excuse me -- just a little bit more than --20 than the month of April of 2022. So we collected more taxes with \$44 million less in wagering. 21 22 So --23 MS. JACKSON: 24 Right. 25 CHAIRMAN JOHNS: 18 1 -- that's what that win ratio 2 will do for you, so . . . 3 So, anyway, thank you very much. Oh, and, also, just publicly, I'll say I did a little 4 5 calculation to date, because everybody is always asking me how much is sports -- sports wagering 6 7 generating for state revenue. Through the end of May, total taxes paid will be \$12,673,778, so 8 9 about 12.6 million in actual taxes paid between 10 retail and mobile. So we're off to a good start. 11 Ms. Jackson, thank you very much for 12 your work. We greatly -- greatly appreciate it. 13 **MS. JACKSON:** 14 You're welcome. 15 V. PRESENTATION ON PROBLEM GAMING BY JANET 16 MILLER, EXECUTIVE DIRECTOR, LOUISIANA 17 ASSOCIATION ON COMPULSIVE GAMBLING 18 CHAIRMAN JOHNS: 19 Okay. I do have an announcement. 20 Janet, come on up to the table and -- before I 21 introduce our next guest. I do want to announce

22 that the National Council on Problem Gambling has

23 approved the 1-800-GAMBLER hotline number and

24 has -- and has adopted it as one of its national

25 numbers. So according to our Louisiana gaming

#### 19

1 statutes, these numbers that are approved by -- by

2 this counsel are actually approved as problem

3 gambling hotline numbers and will, therefore, be

4 approved here in Louisiana.

5 So -- so, ladies and gentlemen, today we have with us a special guest, a lady that I've 6 7 known a long time. I've worked with her back in 8 the Legislature years -- for a number of years and 9 we've developed a very good working relationship. 10 But Janet Miller is the Executive Director for the Louisiana Association of 11 12 Compulsive Gambling. She's located up in the 13 Shreveport/Bossier market, but she operates 14 statewide. Janet has been the Executive Director 15 since 2014. From 2008 until 2014, she was the 16 Deputy Executive Director. She began her work there at this association in 1999. So, Janet, 17 18 welcome to --19 MS. MILLER: 20 Thank you. 21 CHAIRMAN JOHNS: 22 -- to the Gaming Control Board this 23 morning, and we appreciate your hard work. This

24 is an issue that's definitely on our radar screen,

25 and the timing of you being here today is very,

20

- 1 very good; so . . .
- 2 MS. MILLER:
- 3 Thank you. In fact --
- 4 CHAIRMAN JOHNS:
- 5 We'll have to see. I'm not sure --
- 6 we may have a few comments or questions from the
- 7 board.

8 MS. MILLER:

- 9 In fact, I brought my phone so I do
- 10 not go over time, okay, because I assured
- 11 everybody. And in line with, as the chairman,
- 12 good morning, Chairman and Board and, obviously,
- 13 those of you who are special guests.
- 14 I wanted to add to the 1-800-GAMBLER
- 15 conversation, which we were looking at discussing
- 16 with you last month with one of the sports
- 17 wagering providers, was that we actually would
- 18 accept and agree with moving to one posted number
- 19 like that for Louisiana. We have been in those
- 20 negotiations the last ten years with the
- 21 National Council and think it would be best for
- 22 problem gamblers and their families to be able to
- 23 access, across the nation, one number but that
- 24 number gets routed to Louisiana to our help line
- 25 that we answer.

## 21

1 What I would ask for is to not post

everything set up to accept that number at our help line. And that is something that we're working on currently with the National Council. And just so you know, we also answer the National Council of Problem Gambling's help line and have done so for almost 20 years as well. So we're in -- working in tandem and 10 want that one number to be much easier to remember for people, but we want to make sure that 11 12 everything is set up that it properly gets routed to Louisiana, because as more and more states will 13 be using that number, then we don't want it to get 14 confusing and people get to the wrong place, which 15 is never a perfect system, with cell use 16 especially, but we do the best we can, and every 17 18 other state does as well. And there are 26 help 19 lines across the US, which makes it crazy if 20 you're traveling, and it would be very nice to 21 eventually move to 1(800) GAMBLER, if that is the 22 number everybody moves to, so that people can be wherever they are and -- and just to remember, oh, 23 24 I need to call 800-GAMBLER. So we do support 25 that. 22 We have taken polls from patients, as

2 the number too soon, until we have the routing and

3

1 well as alumnae, staff, and family members over 2 3 the last two years to see, out of the three 4 numbers, which they believe would be easiest to

- 5 remember from the Louisiana Problem Gamblers
- 6 number, which would remain open, because it is
- 7 posted everywhere. So we will not shut that
- 8 number down. We would just route it through the
- 9 1(800) as well and have that come to us, or the
- 10 help line number for NCPG, which is

11 1(800) 522-4700, and they chose 800-GAMBLER as far

- 12 as ease of when you're stressed or when you're
- 13 looking for something. So I do support that
- 14 numeric organization. Our Board of Directors do
- 15 as well.
- 16 Bear with me a little bit. Just so
- 17 you know, as the Chairman said, we developed the
- 18 Louisiana Association of Compulsive Gambling in
- 19 1996 with the sole purpose to treat people who
- 20 need prevention, education, counseling, help find
- 21 services or resources. What we knew, when working
- 22 with the Louisiana Department of Health, the
- 23 Gaming Control Board, and all the gaming industry
- 24 during that time, was that people who wouldn't be
- 25 having fun with it anymore, who needed to talk to

- 1 someone like us, would need somewhere to go.
- 2 And so we actually opened in 1999
- 3 CORE Center of Recovery, the first residential
- 4 treatment center that is free for Louisiana
- 5 residents to attend as adults for problem gambling
- 6 or gambling disorder. What we have done with
- 7 that, since 1999, is treated over 6,000 people and

8 over probably 10,000 family members who have been

9 involved with that as well.

10 Also, we worked with the Louisiana Department of Health, the different districts or 11 12 regions throughout the state to have counselors 13 and treatment and trainings for people who would work with problem gambling. It is a different 14 15 type of addiction to work with, and I added this 16 part about LACG to your left of your packet. 17 I also gave Wade Duty one. He has 18 been a strong supporter, as their whole organization has been, and so that's what he has 19 20 back there. You're probably wondering what I gave 21 him. 22 What I did want to mention was, in 2006, LACG launched with Bossier-Webster Parish a 23 24 pilot gambling treatment referral program. We did 25 that program for two years, and the program was 24 1 highly successful. Everybody who had a crime 2 directly related to their gambling -- of course,

3 they would have to admit that to the defense

4 attorney, to the judge, the prosecution. And so

5 in lieu of going to jail or prison, they were sent

6 to CORE and then followed for up to two years in

7 outpatient gambling counseling or longer if the

8 Court or we determined that, or the other parishes

9 did, for their health. It's highly successful,

10 and it was a great program that we would like to

- 11 have again, depending on if we have a judge and
- 12 some prosecutors and DAs that want to do that.
- 13 But in 2017, the Attorney General's
- 14 team, under the leadership of Chris Hebert, and,
- 15 certainly, Suzanne deserves much credit as well,
- 16 developed a program that's called the
- 17 Problem Gambling Resource Services. That program
- 18 is excellent in nature of helping not only those
- 19 who have problems but also lawyers, people in the
- 20 legal field. We know that there is a high rate of
- 21 stress and indication with those professionals who
- 22 may have also access to money. And so we want to
- 23 make sure we're educating them and providing
- 24 services. So I really appreciate the Attorney
- 25 General working with us and his Gaming Division

- 1 team, since 2017, on that.
- 2 Just so you know that also for about
- 3 20 years, as I stated earlier, LACG has worked
- 4 with the National Council, because we are the
- 5 state affiliate to the National Council. So our
- 6 Council is the voice for us in national things,
- 7 and I've been on the board and have been involved
- 8 with them since 2000.
- 9 What we want to do is work towards a
- 10 much more generalization of proper treatment and
- 11 help line services and work that we can do, not
- 12 only do in Louisiana but across the nation, so
- 13 that we can bring to the board different items, as

14 well as the industry, and working together, like 15 we always have in Louisiana, to make sure that our 16 people are taken care of, because most people we 17 know, almost 95 or 97 percent of the population 18 who gamble will never develop a problem with 19 gambling, but the 3 to 5 percent that do, then we 20 want to make sure we provide help for them and 21 resources and proper training from people who 22 understand this addiction and understand how to 23 speak to it and to help with that. 24 What has been a challenge, 25 certainly, -- since sports wagering has not ever 26 not been around. Right? It's always been around, 1 but it's been around now in a much more national, 2 fluid way -- is that it has increased the call 3 4 volume for the national number up about

5 13 percent. We're seeing that 13 percent call

6 volume and text and chat volume since 2021. We

7 are also seeing text and chat for the national

8 numbers going up about 43 percent. So as more

9 people are accessing their phones and doing things

10 with texts and chat online, we're able to answer

11 that at the help line, but, also, that is

12 exponentially going higher.

13 What you see on the right side of

14 your packet are -- is information for the last

15 five years for Louisiana. And what we put in

16 there was not all the information we gather from

- 17 every caller or certainly intake. An intake is a
- 18 process of somebody who says, I'll sit and talk to
- 19 you longer, than just some information to get a
- 20 resource to a support system or a counselor or
- 21 some kind of mechanism of help. So there is
- 22 someone who will give us more information. Well,
- 23 this is not only the call, text, and chats, but
- 24 it's also from the intakes.
- 25 What you will see in the pandemic

- 1 years of March -- for March 2020, when the
- 2 pandemic was announced and there was a shuttering
- 3 down of things, you will see a decrease of calls,
- 4 texts, and chats for the next year, year and a
- 5 half; however, what didn't decrease was the fact
- 6 that people started gambling at a higher rate when
- 7 they did go back, it seemed like.
- 8 So what they were reporting when they
- 9 started calling us again was, we thought because
- 10 we weren't gambling for a few months or six
- 11 months, however long, or the family would call us
- 12 oftentimes, that they were misled by that, by the
- 13 fact that they do have a problem. And so the --
- 14 the numbers also don't show the second part of
- 15 this.
- 16 In 2022 in January, when sports
- 17 wagering went online, we had over 800 calls,
- 18 texts, and chats from people who just want to know
- 19 about their sportsbook or their money that they

20 won. So, yes, they won some good money and stuff.

21 The problem was they thought we were it to call,

22 because we are a help line listed. Then it got

23 worse in February. It went over 2,000 calls,

- 24 texts, and chats. So our staff was ready to
- 25 probably leave the employment. So this is like,

#### 28

1 who are we working for? And I said, okay. Wait.

So I reached out, obviously, fairly
quickly in January, because that's a really high

4 call volume. We get casino calls, we get video

5 poker calls. We get stuff like that, and we

6 generate that in, but that's not in the numbers

7 that you have on the left, because it was so high,

8 and it was literally people -- sometimes we know

9 that -- when they call, we don't know if it's a

10 problem gambling call or if it's somebody for a

11 sportsbook now. Right? So we have to answer it

12 like it's a problem gambling call.

13 And so sometimes people will stay on

14 the phone and ask a few questions. That's nice.

15 Most of the time, they hang up or let us go. But

16 then in March, it -- it dropped down -- thank

17 you to the industry, sportsbooks, everybody I

18 contacted -- to about over 500.

19 We're still getting those calls,

20 which are not helpful to our team, who are not

21 wanting to do that kind of work when they have all

22 these other calls to answer to. But I do

- 23 appreciate that everybody I contacted, and even
- 24 your chairman as well -- everybody helped,
- 25 Wade Duty. Everybody was -- was working on this

- 1 from all the different providers as well.
- 2 I think it's important to notice

3 throughout the packet that I gave you, again, is

- 4 this is not all the information for the Louisiana
- 5 call line for five years, but we thought it might
- 6 be important for you to see that certain times of
- 7 certain higher call or contact and that -- and
- 8 that that doesn't necessarily mean anything other
- 9 than I think it means that people are willing to
- 10 get help and get services. What you can connect
- 11 it to is certain sports events.
- 12 March is usually our highest call
- 13 volume in the Louisiana Problem Gambling help
- 14 line. We do problem gambling awareness month. So
- 15 we have lots of activities, lots of events, lots
- 16 of community things in that. So it would generate
- 17 more looking and seeing that number, we believe.
- 18 But the two years it did not hit the
- 19 highest call volume was during the pandemic. We
- 20 did not do activities, as most people were not
- 21 comfortable with in-person events. We shifted
- 22 some to -- the next year, some social media
- 23 events, but it was not the same.
- 24 The other thing to note is that our
- 25 people that call us tell us other issues that are

1 going on, but the number one reason that it's 2 stayed consistent throughout the last five years, and probably longer, if I look back at what I 3 4 polled for statistics, is a call for financial 5 stress, 77 percent of the callers. 6 So when we have someone who is under 7 financial stress, they're calling us, and that's 8 the number one reason, and so we want to get them 9 some help. And that's why we've added two 10 different components with treatment and services for budget planning, financial help, resourcing 11 12 out there that people could also help them when they stop gambling. That's a consistent stressor. 13 14 The males and females for Louisiana are staying relatively the same amount of 15 16 percentage callers, but the two ethnicities that 17 call the most in the last five years, and it's 18 been that way most of the years we've been open 19 since 2000, and we've answered, so you know, 20 1.8 million calls, texts, and chats since 2000, is that the top two ethnicities are Caucasian and 21 22 African-American. I've added the top five, but 23 they're not nearly, as you look at the other 24 ethnicities, as high a call volume or reaching 25 out.

## 31

1 And then I put in there the -- it's

2 important for us sometimes to note the game or the

3 play of choice that they do, and I put that information in there, but also note that the age 4 5 of the gambler who is calling that says they have a problem is going to a younger age now, as is 6 7 those that we're seeing that are showing up for 8 treatment. We're seeing more males in the age 9 range of 25 to 34 who are doing sports, sports 10 wagering, sports online, and it's a different way 11 to treat that addiction of that type versus suiting up and going out to a casino and playing 12 13 or even going to some of the video poker places. 14 So we're gearing up to get different 15 training for people in Louisiana and working on that to make sure that we're addressing the 16 17 changes as they come, because it's not going to go 18 away. And, again, most of the people who do 19 gamble do not have a problem, and so have fun and 20 entertain yourself. But those who have a problem 21 are the ones that we want to treat and get to and 22 help. 23 And so we want to make sure that everybody understands that we are not for nor 24 25 against gambling. Our organization has never been 32 1 in that business. We are about treating people who need help for problem gambling and getting 2 them the best resources and treatment available. 3

4 So I am available by way of my card

5 that I left you. Sir, I may have gone four more

- 6 minutes. I apologize. I told them how long, and
- 7 so -- anyway, if you have any questions, I'll be
- 8 around, and I don't want to add any more time to
- 9 the meeting today. You're very busy. So thank
- 10 you for your time today, sir.
- 11 CHAIRMAN JOHNS:
- 12 Well, thank you, Ms. Miller. And,
- 13 like I said earlier, you and I have known each
- 14 other for a long time, and I recognized
- 15 immediately when I became chairman, the incredible
- 16 job that you and your program does.

### 17 MS. MILLER:

- 18 Thank you, sir.
- 19 CHAIRMAN JOHNS:
- 20 Am I not mistaken, but isn't there
- 21 some money in the State Capitol outlay budget this
- 22 year for the possibility of another program down
- 23 in the New Orleans area?
- 24 MS. MILLER:
- 25 We -- there is, and we -- I have had

- 1 discussion with some of the people down there that
- 2 are looking to open a small center for the
- 3 New Orleans area, because it is a high call volume
- 4 area. We actually had CoreSouth, a treatment
- 5 center pre-Katrina, that LACG ran from 20 -- 2001
- 6 to 2005. So I think it's a great idea. And --
- 7 and so, hopefully, they will provide the best kind
- 8 of treatment for problem gambling.

- 9 CHAIRMAN JOHNS:
- 10 Well, I thank the Legislature for
- 11 recognizing that need and also to the governor for
- 12 not vetoing it, for allowing it to stay in
- 13 House Bill 2.
- 14 MS. MILLER:
- 15 l agree.
- 16 CHAIRMAN JOHNS:
- 17 No doubt that it's greatly needed,
- 18 and we're very appreciative of that. Members,
- 19 any -- any comments, any questions from the board?
- 20 MR. SHOLES:
- 21 Thank you, Mr. Chairman. I think you
- 22 actually discussed one of the issues I was most
- 23 concerned about, and that was the availability of
- 24 free services in the Orleans Parish area.
- 25 Assuming that this funding is available, how long

- 1 will it take to get this program up and running in
- 2 Metro New Orleans?

3 MS. MILLER:

- 4 Well, when -- I sent information to
- 5 the Secretary of State and some other people
- 6 involved with these decisions. They already have
- 7 a place that's willing to put the unit there. So
- 8 they could actively -- and some treatment people
- 9 on board. So they could actively start it next
- 10 month, whenever they want to. They have the money
- 11 there. They have -- unless they don't have the

- 12 contract in hand and they're waiting for that, but
- 13 they should be able to start that next month, if
- 14 they wanted to.
- 15 MR. SHOLES:
- 16 And these are, in fact, free
- 17 services. Is that correct?
- 18 MS. MILLER:
- 19 They are supposed to be free
- 20 services, because we contract with the Louisiana
- 21 Department of Health. There are some places that
- 22 say they offer gambling treatment services around
- 23 the state, and then when the people show up there,
- 24 it's not free. That's because they're not a
- 25 contractor to provide the free services.

#### 1 MR. SHOLES:

- 2 I would appreciate it if someone
- 3 could let us know when that -- when that program
- 4 gets up and running.
- 5 Ms. MILLER:
- 6 I will absolutely send that to the
- 7 chairman.
- 8 MR. SHOLES:
- 9 Thanks for that.
- 10 MS. MILLER:
- 11 Absolutely.
- 12 CHAIRMAN JOHNS:
- 13 And, Judge, I will tell you the way
- 14 that this works, the -- the money we're talking

- 15 about was not a direct appropriation in
- 16 House Bill 1. It was in the capitol outlay
- 17 budget. I think I'm correct in saying that.
- 18 MS. MILLER:
- 19 I believe so, yes.
- 20 CHAIRMAN JOHNS:
- 21 I think so. We had it in
- 22 House Bill 2. In order for that money to be
- 23 accessed, it's got to go through the State Bond
- 24 Commission at some point. It's got to be
- 25 recommended by the Governor's Office to be put on

- 1 the agenda for the Bond Commission. In all just
- 2 my years of experience, probably the earliest you
- 3 would see that would probably be at the October
- 4 Bond -- there's normally a lot of -- a lot of
- 5 stuff on the Bond Commission in October --
- 6 September, October. And so I think that would be
- 7 about the earliest that you would see it go to the
- 8 Bond Commission.

9 And -- but the reality of going

- 10 through capital outlays, you're probably looking
- 11 at about a year to -- to have that -- that funding
- 12 in place, the program up and running and -- and it
- 13 actually working. But it could happen sooner, and
- 14 hopefully it will.
- 15 MS. MILLER:
- 16 And just -- and just so you know --
- 17 CHAIRMAN JOHNS:

18 But the good news is that -- that it

19 was part of -- the first time that I've seen money

- 20 in one of the two money bills for -- for this
- 21 issue. So I think that's good news.
- 22 MS. MILLER:
- 23 Just -- and just so you know, sir, we

24 actually have a program with Greyhound Bus Line

25 that -- LACG pays for Greyhound bus tickets for

#### 37

1 people to get to treatment and get home, because,

2 obviously, no one in New Orleans lives in the

3 Shreveport/Bossier area. So we do that and have

4 done that for most of the time we've been open.

5 And so -- and we have treated

6 people -- obviously, we're a statewide provider.

7 So we have accepted people from all over the state

8 and your area as well, and that's why we started

9 CoreSouth some years ago before Katrina hit.

#### 10 So it's a -- it's a great plan, but

11 that's why they're working right now to get it

12 ready, so as soon as they get everything signed

- 13 and dotted and approved, they can open it.
- 14 MR. SHOLES:
- 15 Thank you.
- 16 CHAIRMAN JOHNS:
- 17 Absolutely. Thank you, Judge.

18 Ms. Miller, thank you for your presentation.

19 MS. MILLER:

20 Thank you.

21 CHAIRMAN JOHNS: Very helpful. Just an incredible program that -- I can't thank you and your staff 24 enough for the professionalism of what you do, 25 so . . . 38 MS. MILLER: Thank you, sir. **CHAIRMAN JOHNS:** You provide a great service to our State. Thank you very much. **VI. CASINO GAMING ISSUES CHAIRMAN JOHNS:** Okay, Members. We're going to move issues. Our first item on the agenda is the consideration of the Petition of a Modification of 12 Debt Transaction for Churchill Downs Louisiana 13 Horceracing Company, LLC. Ms. Jackson, good morning. MS. JACKSON: Good morning again, Chairman Johns, Board Members. Again, I'm Donna Jackson with Louisiana State Police, Gaming Audit Section. In a noticed letter, dated notice dated March 29, 2022, Churchill Downs

March 18, 2022, and by correspondence amending the 20

21

22 Louisiana Horceracing Company, LLC, notified the

23 board of the intent of its parent company,

- Churchill Downs, Incorporated, to enter into new 24
- 25 financing by amendment of its existing credit

agreement. Specifically, Churchill Downs proposed 1 2 to extend the maturity date and increase its 3 revolving credit facility under the existing credit agreement from \$7 million to \$1.2 billion, 4 5 to enter into a new Delayed Draw Term Loan A 6 Facility in the amount of \$800 million under the 7 existing credit agreement, and to issue \$1 billion 8 to \$1.4 billion in the new senior unsecured bonds. 9 After a review of the proposed transaction by the Attorney General's Office and 10 the Louisiana State Police, Gaming Audit Section, 11 it was determined that the issuance of the bonds 12 by Churchill Downs did not require board approval, 13 14 but the proposed new bank financing to be entered 15 into by amendment of Churchill Downs' existing 16 credit agreement requires board approval. 17 Additionally, when the licensee notified the board 18 of the proposed debt transaction, it also requested that Churchill Downs, Incorporated, be 19 20 allowed to close the financing conditioned on later board approval. 21 22 On March 30, 2022, Chairman Johns, by letter, advised the licensee that the financing 23 could be closed pending board approval subject to 24 25 the following conditions: That the licensee would

1 not pledge any collateral or execute any 2 guarantees until board approval; and that neither 3 Churchill Downs, Incorporated, nor any of its subsidiaries, would pledge any of its ownership 4 5 interest in the licensee until Board approval of 6 the proposed financing was obtained. 7 On April 13, 2022, Churchill Downs 8 closed on the financing. This matter is now 9 before the board for its consideration and 10 approval. 11 The purpose of this transaction is to 12 finance Churchill Downs' acquisition of substantially all of the assets of Peninsula 13 Pacific Entertainment, LLC, pursuant to a purchase 14 15 agreement with P2E for working -- working capital requirements and other general corporate purposes, 16 17 including fees and expenses of the transaction. The acquisition does not include any Louisiana 18 19 assets or property. The only considerations for 20 this board today relate to the financing. 21 JPMorgan Chase will remain the 22 administrative and collateral agent under the 23 credit facility. The guarantors and collateral are substantially similar to Churchill's existing 24 25 credit agreement previously approved by the board. 41

1 As of March 31, 2022, Churchill was in compliance

2 with all applicable covenants of its existing

3 credit agreement. Churchill projects sufficient

- 4 cash flows to service the debt in the foreseeable
- 5 future. In conclusion, no financial issues came
- 6 to our attention to preclude the board's approval
- 7 of this transaction.
- 8 If it is the board's pleasure to
- 9 approve the debt transaction, the Attorney
- 10 General's Office has prepared a resolution for
- 11 your consideration, and representatives of Fair
- 12 Grounds are in attendance today should you have
- 13 any questions for the company.

# 14 CHAIRMAN JOHNS:

- 15 Thank you, Ms. Jackson. For the
- 16 record, I may have possibly said Louisiana Downs.
- 17 That's not correct. It's Louisiana Horseracing
- 18 Company, and it's two completely separate
- 19 entities.
- 20 Members, Ms. Jackson did explain that
- 21 this acquisition involved the assets of P2E except
- 22 Louisiana properties. That property, we know here
- 23 in Louisiana, is DiamondJacks up in Bossier City.
- 24 So it's my understanding that Churchill Downs
- 25 acquired all the assets of P2E except DiamondJacks

- 1 up in Bossier City. I think I'm pretty much
- 2 right.
- 3 MS. JACKSON:
- 4 I believe so. You'll see on page 3,
- 5 it has a listing of the -- of the properties that
- 6 it includes.

- 8 Substantially, --
- 9 MS. JACKSON:
- 10 Substantially.
- 11 CHAIRMAN JOHNS:
- 12 -- all the other assets but it does

13 not include the DiamondJacks property, which we

- 14 know is a whole different issue before -- before
- 15 this board. It's pending right now. So any
- 16 questions from the board members?
- 17 (NO RESPONSE)
- 18 CHAIRMAN JOHNS:
- 19 We do have someone from Churchill
- 20 Downs that is here today. Mr. Waguespack, I
- 21 think, is here. Any questions for Mr. Waguespack?
- 22 (NO RESPONSE)
- 23 CHAIRMAN JOHNS:
- 24 Okay. I -- I have no questions,
- 25 Members. At this time I would entertain a motion

- 1 that we adopt the resolution that's before you.

- 2 by the Board and executed by its Chairman on that

3 date; and

4 Whereas, on March 18, 2022,

- 5 Churchill Downs, Inc., requested Board approval of

- 9 to the refinancing of the outstanding indebtedness
- 10 of Churchill Downs, Inc., requires prior Board

11 approval.

12 Now, therefore, be it resolved that

13 an increase of its revolving credit facility from

14 \$700 million to \$1.2 billion and the transactions

- 15 contemplated thereby is hereby approved.
- 16 Be it resolved that a new Senior
- 17 Secured Term Loan A facility in the amount of
- 18 \$800 million is hereby approved.
- 19 Be it resolved that the perspective
- 20 incremental facilities, as more particularly
- 21 described in the existing credit agreement and the
- 22 transactions contemplated thereby, are hereby
- 23 approved.
- 24 Thus done and signed in Baton Rouge,
- 25 Louisiana, this 16th day of June 2022.

25	Treasure Chest Casino.

1	MR. MEEK:
2	Good morning, Chairman Johns.
3	CHAIRMAN JOHNS:
4	Good morning, Matthew. How are you
5	this morning?
6	MR. MEEK:
7	Doing well, doing well. Members of
8	the Board, I'm Assistant Attorney General
9	Matthew Meek, present today in the matter of
10	Treasure Chest Casino, LLC's, submission of their
11	architectural blueprints and plans of design.
12	On December 16, 2021, this board
13	considered and approved the licensee's request to
14	relocate its gaming operations to a landside
15	facility within 1,200 feet of its licensed berth.
16	On that date, the board adopted a resolution that
17	required the licensee to submit the architectural
18	blueprints and plans of design within 90 days of
19	that approval to move landside. The licensee did
20	timely submit those documents, and those plans are
21	up for your consideration today.

- 22 As a reminder, in addition to the
- 23 gaming floor, the landside facility will include a
- 24 multipurpose event center with seating for a
- 25 minimum of 300 people, a sports bar, a minimum of

- 1 two -- a minimum of two restaurants, and a coffee
- 2 house or quick service food facility. The
- 3 Louisiana State Police, Gaming Enforcement
- 4 Division, and the Attorney General's Office
- 5 reviewed the plans and confirmed that they contain
- 6 all of the elements of the approved project.
- 7 If it is the board's pleasure to
- 8 approve the plans, a resolution has been drafted
- 9 for your consideration. The licensee will then
- 10 have 90 days from signature of that resolution to
- 11 submit their construction contracts, and then that
- 12 would be considered by the board at a future date.
- 13 A representative of the licensee is present today
- 14 to make a statement and answer any questions that
- 15 you may have.
- 16 CHAIRMAN JOHNS:
- 17 Okay. Thank you, Mr. Meek, and we
- 18 have someone from Boyd that's here this morning, I
- 19 think, with Treasure Chest. Good morning.
- 20 MS. BOLES:
- 21 Good morning, Mr. Chairman and Board
- 22 Members. Janet Boles on behalf of Boyd Gaming.
- 23 With me is Vince Schwartz, who is Regional
- 24 Vice-President on behalf of Boyd, and Kim Etland,

25 who is the GM and Vice-President of

- 1 Treasure Chest.
- 2 CHAIRMAN JOHNS:
- 3 Good morning.
- 4 MS. ETLAND:
- 5 Good morning.
- 6 MR. SCHWARTZ:
- 7 Good morning. Glad to be in front of
- 8 your today. The project is moving forward. We're
- 9 certainly excited to take advantage of this
- 10 opportunity to move the property on land. You
- 11 know, a riverboat -- there's only so much you can
- 12 do with a steel riverboat to update it and upgrade
- 13 it, and it's been around for about 25 years. So
- 14 we are real excited to -- really excited to bring
- 15 it -- bring this project to light and move it on
- 16 land.
- 17 It is a pretty significant upgrade
- 18 and update to what we have today. Similar game
- 19 counts, a little -- a few more table games and a
- 20 few more slots perhaps, but the food and beverage
- 21 element is much better than we currently have
- 22 today. And then having an event center is going
- 23 to be very nice for a property that we've been
- 24 restricted by space for a long, long time.
- 25 We've been parking-challenged. If
  - 50
- 1 anybody has been to the facility, our parking is

2	on the dry side of the levy, with the facility
3	being on the water. So it's about a half-mile
4	walk or a half-mile bus ride. So so this
5	this will really improve our offering and give us
6	a more competitive competitive and compelling
7	product in that market. So we are certainly
8	excited to be there.
9	CHAIRMAN JOHNS:
10	Well, thank you. Kim, good morning.

- 23 Toucan Management, LLC.
- 24 LSM Gaming, Incorporated, has a
- 25 75 percent membership interest in WY Properties,

- 1 LLC, and a 50 percent membership interest in
- 2 United Ventures Unlimited, LLC. Stan Guidroz will
- 3 indirectly hold a 7.5 percent interest in
- 4 WY Properties, LLC, and a 5 percent interest in
- 5 United Ventures Unlimited, LLC.
- 6 Criminal Investigator William Landry
- 7 conducted the suitability investigation and
- 8 updated suitability checks on the associated
- 9 persons. He also conducted an investigation of
- 10 the transfers of interest. He is here today and
- 11 will present the Office of State Police's
- 12 findings.
- 13 MR. LANDRY:

5	we caused notices of intent to be published,

6 directing all individuals with public comments to 7 make said comments to the Attorney General's 8 Office. During the public comment period, no 9 comments were made; therefore, as part of the 10 promulgation process, reports were submitted to 11 the House and Senate oversight committees. 12 The first reports detail the 13 substance of the proposed rules, and the second 14 report simply indicated that no public comments 15 were received. The committees were given 30 days in which to call hearings in order to satisfy any 16 17 concerns that they might have. Since they did not call any oversight committee hearings, the default 18 is to approve the process; therefore, this is 19 before the board today for final promulgation. If 20 the Board votes to approve them today, a motion to 21 22 adopt the rules is needed, and they will be sent 23 to the Registrar's Office and promulgated and 24 published in next month's -- so it will be July 20 is when they will be finalized. 25

- 1 CHAIRMAN JOHNS:
- 2 Okay. And so some of these rules

3 actually fall right into place with what

4 Ms. Miller presented to us today with self -- you

5 know, one of them is the self-exclusion program,

6 the 1(800) -- the number -- the advertising

7 mandate. So okay. Any questions from the Board

- 9 MR. SHOLES:
- 10 Self-exclusion, if a person decides to self-exclude for any particular reason but then 11 later, after a passage of time, feels they're 12 13 prepared to go back, what's the process, and how 14 long does it take to get off the self-exclusion 15 list? 16 MS. HIMEL: 17 So they're on the self-exclusion list 18 for a minimum of five years. They do have to go 19 to -- I'm not sure if it's a psychologist or a 20 psychiatrist, but they do have to get 21 psychologist -- a mental health evaluation to make sure that they are safe for themselves to reenter, 22 you know, the gaming industry, in order to 23 24 participate. 25 Once they do that, they have to go 63 1 before the hearing officer. It is a closed 2 hearing in which they consider all the testimony. 3 They might talk to the person, and they look at the psychologists' reports to show that they did 4 5 complete the psychologist review. And then if the hearing officer determines that they should be 6 7 able to be removed, then they have them removed
- 8 from the self-exclusion list, and they are allowed
- 9 to game again.
- 10 MR. SHOLES:
