COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and Stan's, L.L.C. d/b/a Stan's Truck Stop / Diamond Jubilee, VGL 3601511583 (hereinafter "the Licensec"), do hereby represent and agree as follows:

WHEREAS, on April 6, 2006, the Louisiana Gaming Control Board issued a Notice of Recommendation of Administrative Action to the Licensee alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notice of Recommendation of Administrative

Action are set for hearing on July 10, 2006, before the Louisiana Gaming Control Board

Administrative Hearing Office; and

WHEREAS, the Division and the Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Action:

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:



#### STIPULATIONS

- 1. As a result of Hurricane Katrina, on or about September 2, 2005, the Division disabled the Licensee's video gaming devices.
- 2. On or about November 18, 2005, the Division enabled the Licensee's gaming devices.
- 3. On or about December 14, 2005, the Division conducted an inspection of the Licensee's truck stop facility, Stan's Truck Stop / Diamond Jubilee.
- 4. As a result of the December 14, 2005, inspection, the Division determined the following:
- a. The Licensee did not have a security guard present in the gaming area in violation of LAC 42:XI.2415(B)(1);
- b. The Licensee's restaurant was not fully operational in violation of La. R.S. 27:306(A)(4)(c)(ii); and
- c. The Licensee leased a portion of the truck stop's parking lot in violation of La. R.S. 27:306(A)(4)(c)(iii), and the Licensee admits to the referenced violations.

#### TERMS AND CONDITIONS

- 1. Within fifteen (15) days of the approval of this settlement by the Louisiana Garning Control Board, the Licensee shall pay a civil penalty of Ten Thousand Dollars (\$10,000.00).
- 2. The Division hereby agrees to accept the payment of the above stated penalty in full and final settlement of all violations alleged in the April 6, 2006, Notice of Recommendation of Administrative Action.
- 3. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

- 4. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and the Licensee pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 5. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.
- 6. If approved, however, payment of the above penalty must be submitted to the Division within fifteen (15) days of approval of this settlement by the Board. The failure to submit the civil penalty within fifteen (15) days of approval by the Board shall result in the immediate suspension of the license until such time as the penalty is paid in full.

The parties have read this entire Compromise and Settlement Agreement and agree to all

stipulations and teams and conditions hereof.
