5	knows, every year we're required to
6	negotiate a contract with the between
7	the City and the casino for the payment
8	of support services. And every year, at
9	least since I've been here, we have
10	authorized the maximum payment of \$3.6
11	million.
12	For a variety of reasons over the
13	last few years that amount wasn't always
14	forwarded to the to the City, and to
15	resolve that because the manner of
16	payment will change come August the 1st.
17	The legislature and their supplemental
18	appropriations bill had an amendment
19	that is going to pay approximately
20	\$2.3 million to the City of New Orleans,
21	and that's money that likely should have
22	been paid to the City previously but
23	went into something I'll just, for
24	simplicity purposes, call it their
25	escrow account which at the end of the
	6
1	fiscal year would revert to the General

2 Fund.

3	So the amendment that was offered to
4	the supplemental appropriations was
5	contingent on the on an amendment to
6	that contract the Support Services
7	Contract by this Board, and that's why
8	we're here today. And I think all of
9	you have seen the documents that
10	would it will add the \$2.3 million to
11	the existing previously approved \$3.6
12	million.
13	And I'll entertain a motion to amend
14	the contract in that amount.
15	MR. LAGASSE: So moved.
16	CHAIRMAN JONES: Second? Mr. Stipe.
17	Any objection? [No response.]
18	Without objection, the motion is
19	approved. The payment's approved.
