#### COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and Vincent Catalanotto, Inc. d/b/a Vincent's and That's Amore, Inc. d/b/a Vincent's Italian Cuisine (sometimes hereinafter referred to as "Licensees") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to Vincent Catalanotto, Inc. d/b/a Vincent's and a Notice of Recommendation of Administrative Action to That's Amore, Inc. d/b/a Vincent's Italian Cuisine, alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notices of Recommendation of Administrative Action are set for hearing on May 7, 2008, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Licensees are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notices of Recommendation of Administrative Action:

**NOW, THEREFORE**, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

#### **STIPULATIONS**

- 1. On September 8, 2007, Vincent Catalanotto was arrested by the Kenner Police Department for Misdemeanor Operating a Vehicle While Intoxicated, Municipal Attachment and Following Too Closely.
- 2. Vincent Catalanotto is the 100% owner and president of Vincent Catalanotto, Inc. d/b/a Vincent's and the 60% owner and president of That's Amore Inc., d/b/a Vincent's Italian Cuisine.
- 3. Vincent Catalanotto failed to timely notify the Division of his September 8, 2008, arrest, which is in violation of LAC 42:XI.2417(B)(4).

#### TERMS AND CONDITIONS

- 1. Vincent Catalanotto, Inc. d/b/a Vincent's and That's Amore, Inc. d/b/a Vincent's Italian Cuisine will pay a combined civil penalty of One Thousand Dollars and No/100 (\$1,000.00) in satisfaction of the alleged violations of the Louisiana Gaming Control Law.
- 2. The Division hereby agrees to accept Licensees' payment of the above stated penalty in full and final settlement of the Notices of Recommendation of Administrative Action issued on February 19, 2008.
- 3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigations, violations or assessments of a penalty.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Licensees, regarding the subject matter contained herein and

supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve the same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement shall result in the immediate suspension of Vincent Catalanotto, Inc. d/b/a Vincent's and That's Amore, Inc. d/b/a Vincent's Italian Cuisine licenses without the necessity of further administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.
