**STIPULATIONS**

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereafter the "Division"), and Viet Dang (hereafter "Permittee") do hereby and agree as follows:

1. The Louisiana Gaming Control Board has issued a Notice of Recommendation of Revocation, Order of Immediate Emergency Suspension, and Notice of Hearing dated October 23, 2006, (hereafter the "Notice"), to Permittee alleging violations of La. R.S. 27:28(A)(1) and (2), La. R.S. 27:28(B)(1)(a), La. R.S. 27:28(B)(1)(b), La. R.S. 27:28(B)(2), La. R.S. 27:28(D), and La. R.S. 27:28(F);

2. The issues raised by the Notice are set for hearing on February 8, 2007 before the Louisiana Gaming Control Board Administrative Hearing Office;

3. Permittee agrees to revocation of his Non Key Gaming Employee Permit No. P040001711 and he will not be eligible to re-apply for any approval authorized by the Louisiana Gaming Control Law for a period of sixty months from this date;

4. Permittee agrees that he will not be eligible to re-apply, either individually or as shareholder, member, managing member, partner, revenue, profit or income interest holder or as a person who, in the opinion of the Division, may exercise significant influence of the operations of a Louisiana casino gaming licensee or permittee for any approval authorized by the Louisiana Gaming Control Law for a period of sixty months from this date;


