COMPROMISE AND SETTLEMENT AGREEMENT

The Louisiana State Police Gaming Enforcement Division (hereinafter, the "Division") and Golden Nugget Lake Charles, LLC d/b/a Golden Nugget Lake Charles (hereinafter, "Licensee"), do hereby represent and agree as follows:

WHEREAS, the Division has sent a Notice of Violation and Penalty to the Licensee, which Notice contains allegations of certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notice were set for hearing before the Louisiana

Gaming Control Board Administrative Hearing Office on January 10, 2024; and

WHEREAS, both parties agreed to continue without date on the Licensee's request for a Continuance at the held administrative hearing; and

WHEREAS, the Division and Licensee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with said Notice;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

The Licensee holds a Riverboat Gaming License and is located at 2550 Golden
 Nugget Blvd, Lake Charles, Louisiana 70601.

- 2. On May 19, 2022 and June 6, 2022, the Licensee notified the Division of multiple thefts on property that were carried out by gaming employees.
- 3. A Significant Action Report ("SAR"), SAR# 22-2-43-139-1898, was issued to the Licensee for multiple violations discovered throughout the Division's investigation into the thefts.
- 3. After a thorough review and investigation into the thefts, the Division discovered the following violations:
 - i. Multiple cage employees wearing pants with unsewn pockets while in the cage area;
 - ii. Licensee was not properly tracking retail/food and beverage variances;
 - iii. Licensee failing to retain gaming paperwork for the requisite five (5) year period;
 - iv. The surveillance department was allowing employees access to the review room who did not have access to the room according to the Licensee's Internal Controls; and
 - v. Inadequate surveillance camera coverage in the Main Cage Office and in the cage area where cassette fill process occurred.

TERMS AND CONDITIONS

 In lieu of administrative action or other regulatory action against its Gaming License, Licensee agrees to pay a civil penalty of THIRTY THOUSAND and 00/100 (\$30,000.00) DOLLARS for its violations of Gaming law.

- 2. The Division hereby agrees that payment of a total penalty of THIRTY

 THOUSAND and 00/100 (\$30,000.00) DOLLARS shall be in full and final settlement of all matters set forth in the Notice of Violation and Penalty.
- 3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Licensee's suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Licensee, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.
- 7. If approved, Licensee agrees to make full payment of the civil penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board.

 Licensee agrees that failure to meet this requirement shall result in immediate suspension of the gaming license without the necessity of any further administrative action until such time as the penalty is paid in full.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.
