COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Tyishika Murray (hereinafter "Permittee") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Revocation and Order of Immediate Emergency Suspension ("Notice") to Permittee alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice are set for hearing on May 13, 2009, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Permittee are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

- 1. Permittee admits that she was arrested on November 15, 2008, on two warrants issued by authorities in the Second Parish Court of Jefferson for violation of La. R. S. 14:71, Issuing Worthless Checks. Charges stemming from this arrest were dismissed on February 4, 2009.
- 2. Permittee admits to violating LAC 42:VII.2901(B)(4) when she failed to notify the Division of her arrest within fifteen (15) calendar days.

TERMS AND CONDITIONS

- 1. Permittee will pay a civil penalty of Two Hundred Fifty and No/100 (\$250.00) Dollars.
- 2. The Division hereby agrees to accept Permittee's payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Revocation and Order of Immediate Emergency Suspension issued on February 18, 2009.
- 3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Permittee, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.
- 6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board, and to comply with each term and condition listed herein, shall result in the continued suspension of Permittee's permit without the necessity of further administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.
