LOUISIANA GAMING CONTROL BOARD

Minutes of November 13, 2025

The monthly meeting of the Louisiana Gaming Control Board (the "Board") convened on Thursday, November 13, 2025, 10:00 a.m., at the Louisiana State Capitol – House Committee Room 1. Present at the meeting were Chairman Christopher Hebert, Kathryn Becnel, Franchesca Hamilton-Acker, Miquell Hennigan, Claude Jackson, Nicholas Langley, Julie Lewis, Ronald Sholes, and Ashley Traylor. Major Adam Albright was present for Col. Robert Hodges and Jarrod Coniglio was present for Sec. Richard Nelson. Absent were ex officio members Col. Hodges and Sec. Nelson.

Chairman Hebert called the meeting to order. There were no public comments made. It was moved by Mr. Jackson to waive the reading and approve the minutes of the October 16, 2025 Board meeting. That motion was seconded by Ms. Becnel and unanimously approved by the Board.

Donna Jackson, Louisiana State Police ("LSP") Gaming Audit Section, provided revenue reports for the riverboats, slots at the racetracks, and land-based casino. She also reported on video poker, retail and mobile sports wagering, and daily fantasy sports contest revenue.

Kanick Lewis, Jr., Assistant Attorney General, presented procurement and employment compliance reports for riverboats and slots at the racetracks for the 3rd Quarter of 2025.

The Board considered the Certificate of Compliance for the Alternate Riverboat Inspection of the gaming vessel for Golden Nugget Lake Charles, LLC d/b/a Golden Nugget Lake Charles – No. R016502995. After presentation by Kanick Lewis, Jr., Assistant Attorney General, and John Francic, Director of Operations for American Vessel Services, LLC ("AVS"), it was moved by Ms. Hamilton-Acker to approve the issuance of an annual certificate of compliance for the riverboat gaming vessel. That motion was seconded by Ms. Becnel and unanimously approved by the Board.

The Board considered the Certificate of Compliance for the Alternate Riverboat Inspection of the gaming vessel for PNK (Bossier City), LLC d/b/a Boomtown Bossier City – No. R016500701. After presentation by Kanick Lewis, Jr., Assistant Attorney General, and John Francic, Director of Operations for AVS,

it was moved by Ms. Traylor to approve the issuance of an annual certificate of compliance for the riverboat gaming vessel. That motion was seconded by Ms. Lewis and unanimously approved by the Board.

The Board considered the Certificate of Compliance for the Alternate Riverboat Inspection of the gaming vessel for Red River Entertainment of Shreveport, LLC d/b/a Sam's Town Hotel and Casino – No. R016500097. After presentation by Kanick Lewis, Jr., Assistant Attorney General, and John Francic, Director of Operations for AVS, it was moved by Mr. Jackson to approve the issuance of an annual certificate of compliance for the riverboat gaming vessel. That motion was seconded by Ms. Becnel and unanimously approved by the Board.

The Board considered the Petition to Commence Gaming Operations filed by Catfish Queen, LLC d/b/a Belle of Baton Rouge – No. R011700009. Presentations were made Delancey Houston, Assistant Attorney General; Attorney Jeff Barbin; Richard Cannon, General Manager; and Stacy Stagg, Vice-President of Operations for Bally's Corporation. After discussion, it was moved by Ms. Hamilton-Acker to adopt the resolution approving the requests. That motion was seconded by Mr. Langley and unanimously approved by the Board.

The Board considered the Compulsive Gambling Program Updates for Catfish Queen, LLC d/b/a Belle of Baton Rouge — No. R011700009. After presentation by Talibah McIntyre, Assistant Attorney General, it was moved by Mr. Langley to adopt the resolution approving the problem gambling program. That motion was seconded by Ms. Becnel and unanimously approved by the Board.

The Board considered the sports wagering license application for Catfish Queen, LLC d/b/a Belle of Baton Rouge – No. W011703486. After presentations by Amy Pirtle Danageozian, Assistant Attorney General; Lisa Hotard, LSP Gaming Audit Section; and Criminal Investigator Rodney Perkins, LSP Gaming Enforcement Division, it was moved by Ms. Traylor to approve the sports wagering license. That motion was seconded by Ms. Hennigan and unanimously approved by the Board.

The Board considered the Responsible Gaming Program Updates for DK Crown Holdings, Inc. d/b/a DraftKings – No. B016503468. After a presentation by Virginia Evans, Assistant Attorney General, it was moved by Ms. Lewis to adopt the resolution approving the problem gambling program. That motion was seconded by Ms. Traylor and unanimously approved by the Board.

The Board considered the petition filed by Radar Labs, Inc. for approval of Two Sigma Ventures III, L.P. to qualify as an institutional investor – No. P016503583. Robert Moncrief, Senior Director of Compliance for Radar Labs, Inc. was present on behalf of the petitioner. After presentations by Talibah McIntyre, Assistant Attorney General; Master Trooper Brian Jefferson, LSP Gaming Enforcement; and Robert Moncrief, it was moved by Ms. Becnel to adopt the resolution approving Two Sigma Ventures III, L.P. as an institutional investor. That motion was seconded by Mr. Langley and unanimously approved by the Board.

The Board considered petition filed by Radar Labs, Inc. for approval of Accel XIII, L.P. and Accel Growth Fund VI, L.P. to qualify as an institutional investors – No. P016503583. Robert Moncrief, Senior Director of Compliance of Radar Labs was present on behalf of the petitioner. After presentations by Talibah McIntyre, Assistant Attorney General; Master Trooper Brian Jefferson, LSP Gaming Enforcement; and Robert Moncrief, the Board was presented with a resolution for each investor. First, it was moved by Mr. Jackson to adopt the resolution approving Accel XIII, L.P. as an institutional investor. That motion was seconded by Mr. Jackson to adopt the resolution approved by the Board. Next, it was moved by Mr. Jackson to adopt the resolution approving Accel Growth Fund VI, L.P. as an institutional investor. That motion was seconded by Mr. Langley and unanimously approved by the Board.

The Board considered the transfer of membership interest in S&A Truck Stop, LLC d/b/a Kings Club – No. 0900514329. After presentation by Amy Pirtle Danageozian, Assistant Attorney General, and Investigator William Landry, LSP Gaming Enforcement Division, it was moved by Mr. Jackson to approve the transfer of membership interest in the licensee. That motion was seconded by Ms. Becnel and unanimously approved by the Board.

There being no further business, it was moved by Mr. Jackson to adjourn the meeting. That motion was seconded by Ms. Hamilton-Acker and unanimously approved by the Board. The meeting was adjourned.
