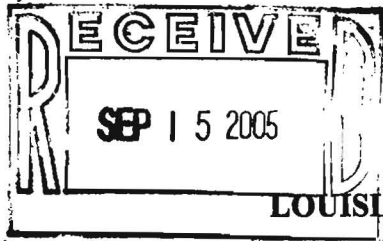

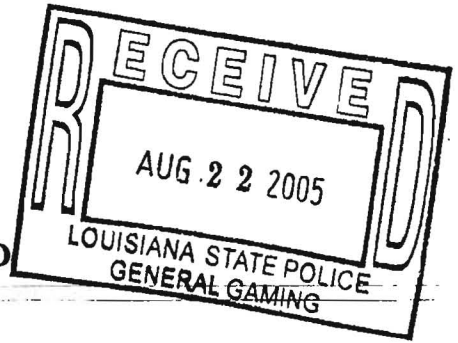

JOINT MOTION FOR ENTRY OF STIPULATIONS AND APPROVAL OF PROPOSED SETTLEMENT

LGCB
ADMINISTRATIVE HEARING OFFICE

ON THE JOINT MOTION OF:

1. the State of Louisiana, Department of Public Safety and Corrections, Office of State Police, (hereinafter "Division"), and
2. FRANKLIN SOUTHLAND PRINTING CO., Permit No. P082602384 (hereinafter "permittee"),

who respectfully represent the following:

WHEREAS:

1. The permittee was required to submit an annual fee and Annual Affidavit by March 21, 2005, which date is its permit anniversary date. As of June 3, 2005, the permittee had not submitted the required fee and affidavit.
2. The permittee is mandated by La. R.S. 27:29 and 27:29.3 to pay an annual fee by its anniversary date.
3. Permittee was issued a *Notice of Recommendation of Suspension and Penalty* by the Louisiana Gaming Control Board.
4. This matter has been scheduled for hearing on September 7, 2005, at 9:00 a.m. before the Honorable William H. Brown.

NOW THEREFORE, in consideration of the foregoing stipulations, the Division and the permittee hereby propose the following settlement, that:

1. The permittee acknowledges that La. R.S. 27:29 and 27:29.3 mandate a permittee to pay an annual fee by its anniversary date;
2. The permittee did not provide the annual fee and Annual Affidavit to the Division until on or around August 1, 2005 ;

3. In lieu of suspension of the permittee's non-gaming supplier permit, the permittee shall pay total penalties of \$562.50, to wit: a \$500.00 civil penalty and a penalty of \$62.50 pursuant to La. R.S. 27:29.5(C);

4. The Division hereby agrees to accept the permittee's payment of the above stated penalties in full and final settlement of this Notice of Recommendation of Suspension and Penalty;
5. The Division reserves the right to take into consideration these violations in connection with any future violation;
6. The form and substance of this settlement are to be interpreted under the laws of the State of Louisiana;
7. This settlement constitutes the entire agreement between the Division and FRANKLIN SOUTHLAND PRINTING CO. pertaining to the subject matter contained herein, and supercedes all prior and contemporaneous agreements, representations, and understandings of the parties;
8. This settlement is subject to approval by the Hearing Officer of the Louisiana Gaming Control Board; it is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not executory and will be submitted to the Board for its determination as to whether the matter should be heard by the Hearing Officer; if approved, however, payment of the above penalties must be submitted to the Division within fifteen (15) days of approval of this settlement by the Board; the failure to submit the penalties within fifteen (15) days of approval by the Board shall result in the permittee being suspended until such time as the penalties are paid in full; and
9. The Division and the permittee waive their rights to appeal this settlement if the Order is signed by the Hearing Officer and accepted by the Board.

Considering the foregoing Joint Motion for Entry of Stipulations and Approval of Proposed Settlement, IT IS HEREBY ORDERED that such proposed settlement be approved, to wit:

1. The permittee acknowledges that La. R.S. 27:29 and 27:29.3 mandate a permittee to pay an annual fee by its anniversary date and the permittee did not provide the annual fee and Annual Affidavit to the Division until on or around August 1, 2005;
2. the permittee shall pay total penalties in the amount of \$562.50, to wit: a \$500.00 civil penalty and a penalty of \$62.50 pursuant to La. R.S. 27:29.5(C);
3. payment of the above penalty shall be submitted to the state within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board; and
4. the failure to submit the above penalty within fifteen (15) days of approval of this settlement by the Board shall result in the Non-Gaming Supplier Permit of the permittee being suspended until such time as penalty is paid in full.
