COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State

Police (hereinafter, the "Division") and Lee Clark, Inc. d/b/a Weegee's Tavern (hereinafter, "Lee

Clark, Inc."), do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has sent a Notice of Recommendation

of Revocation to Lee Clark, Inc., which Notice contains allegations of certain violations of

Louisiana Gaming Control Law; and

WHEREAS, the issues raised by said Notice are set for hearing before the Louisiana

Gaming Control Board Administrative Hearing Office on August 13, 2012; and

WHEREAS, the Division and Lee Clark, Inc. are desirous of fully and finally

compromising and settling all issues and disputes arising out of and in connection with said

notice;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby

agree and stipulate as follows:

#### STIPULATIONS

- On July 20, 2011, the Louisiana Department of Revenue notified the Division that Lee Clark, Inc., Carlos Torres, and Louis Todaro were delinquent in the filing and payment of their Louisiana state returns and taxes.
- On October 25, 2011, the Division notified Lee Clark, Inc., Carlos Torres, and Louis Todaro by certified mail of their delinquency.<sup>2</sup>
- On May 25, 2012, Lee Clark, Inc., Carlos Torres, and Louis Todaro were each granted a tax clearance by the Louisiana Department of Revenue.<sup>3</sup>

#### TERMS AND CONDITIONS

- In lieu of revocation, Lee Clark, Inc. will pay a penalty of FIVE HUNDRED DOLLARS and No/100 (\$500.00) for its violation of LAC 42:XI.2405(B)(1)(b).
- 2. The Division hereby agrees that payment of a penalty of FIVE HUNDRED DOLLARS and No/100 (\$500.00) shall be in full and final settlement of all matters set forth in the Notice of Recommendation of Revocation for Lee Clark, Inc.'s violation of LAC 42:X1.2405(B)(1)(b).
- 3. The Division reserves the right to take into consideration this admitted violation in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Lee Clark, Inc.'s suitability.
- 4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
- 5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Lee Clark, Inc., pertaining to the subject matter contained herein and

supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

7. If approved, Lee Clark, Inc. agrees to make full payment of the civil penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board. Lee Clark, Inc. agrees that failure to meet this requirement shall result in immediate suspension of the Type 1 video draw poker gaming license without the necessity of any further administrative action until such time as the penalty is paid in full.

I have read this entire Compromise and Settlement Agreement and agree to all stipulations and terms and conditions hereof.
