JOINT MOTION FOR ENTRY OF STIPULATIONS AND APPROVAL OF PROPOSED SETTLEMENT

ON THE JOINT MOTION OF:

- 1. The Louisiana Department of Public Safety and Corrections, Office of State Police, Video Gaming Division (hereinafter "Division"), through the undersigned Assistant Attorney General, and
- 2. PNK (Bossier City), Inc., d/b/a Boomtown Bossier, hereinafter Boomtown-Bossier,

who respectfully enter the following stipulations into the record:

WHEREAS:

- 1. For the period of September 21, 2001 to November 25, 2001, the Division noted eleven (11) incidents of Boomtown-Bossier's failure to secure assets. These incidents involved open/unsecured slot machine doors, open/unsecured BVA access doors and open/unsecured drop doors.
- 2. Pursuant to this information, on or about July 23, 2002, the Division issued a Notice of Violation and Penalty to Boomtown-Bossier, based on the provisions found in LAC 42:XIII.2715(A)(1);

- 3. On or about August 1, 2002, Boomtown-Bossier requested an administrative hearing of this action before the Louisiana Gaming Control Board's hearing officer; and
- 4. This matter has been placed on Hearing Officer William H. Brown's docket for hearing on November 13, 2002 at 9:00 a.m.

NOW THEREFORE, in consideration of the foregoing Stipulations, the Division and Boomtown-Bossier hereby propose the following settlement:

- 1. Boomtown-Bossier admits that it violated LAC 42:XIII.2715(A)(1).
- 2. Boomtown-Bossier will pay, as a civil penalty for non-compliance, the sum of TWENTY THOUSAND DOLLARS AND NO CENTS (\$20,000.00).
- 3. Subject to the approval of the Hearing Office of the Louisiana Gaming Control Board, the Division hereby agrees to accept Boomtown-Bossier's payment of the above stated penalty in full and final settlement of this administrative action;
- 4. It is expressly understood that this proposed settlement, if approved by the Hearing Officer, is not executory and will be submitted to the Louisiana Gaming Control Board for its determination as to whether the matter should be heard by the Hearing Officer. The parties hereby consent to this procedure.
- 5. The Division and Boomtown-Bossier waive their rights to appeal this Stipulation if the Order is signed by the Hearing Officer and is accepted by the Louisiana Gaming Control Board;
- 6. The Division reserves the right to take this matter into consideration in connection with any subsequent violations;

- This settlement is to be interpreted under the laws of the State of Louisiana; and 7.
- This settlement constitutes the entire agreement between the Division and 8. Boomtown-Bossier pertaining to the subject matter contained herein and supercedes all prior and contemporaneous agreements, representations, and understandings of the parties.
