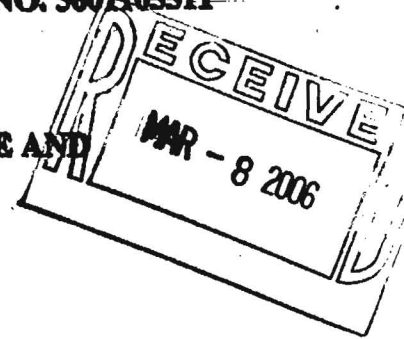



COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and Pete and Lou, Inc. d/b/a Half Moon Bar & Grill, VGL 3601105511, do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to Pete and Lou, Inc. d/b/a Half Moon Bar & Grill, which notice alleges certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing on March 7, 2006, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the parties hereto are desirous of fully and finally compromising and settling all disputes and issues raised in connection with the said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. Pete and Lou, Inc. d/b/a Half Moon Bar & Grill, a licensed video gaming establishment, previously entered into a video poker device agreement with Master Video Poker.

2. Master Video Poker sent video gaming documents ("the Documents") to Pete and Lou, Inc. d/b/a Half Moon Bar & Grill for execution, including but not limited to the Annual license form, dated May 2, 2003, which was signed by Haluk Dogru.

3. Haluk Dogru is the owner of Pete and Lou, Inc. d/b/a Half Moon Bar & Grill.

4. Haluk Dogru admits that he did not sign the Documents in the presence of a notary and the Documents were not notarized in the Affiant's presence. Thus, the Documents were improperly notarized in violation of LAC 42:XI.2405(A)(15).

5. On December 14, 2005, the Louisiana Gaming Control Board issued a Notice of Recommendation of Administrative Action to Pete and Lou, Inc. d/b/a Half Moon Bar & Grill, VGL 3601105511, alleging certain violations of Louisiana Gaming Control Law.

6. Haluk Dogru represents that all of the statements, responses, disclosures and representations provided in documents submitted to the Division bearing his signature, are true and correct to the best of his knowledge, information and belief, and represent a complete and accurate account of the requested information.

TERMS AND CONDITIONS

1. Any and all information discovered throughout the course of this or any other investigation may be used in any future determination of the suitability of Haluk Dogru.

2. Pete and Lou, Inc. d/b/a Half Moon Bar & Grill agrees to pay a civil penalty of One Thousand Dollars (\$1,000.00).

3. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Pete and Lou, Inc. d/b/a Half Moon Bar & Grill, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.


4. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory,

but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.


5. If approved, Pete and Lou, Inc. d/b/a Half Moon Bar & Grill must make payment of the civil penalty to the Division within ten (10) days of approval by the Louisiana Gaming Control Board. Failure to do so shall result in the immediate suspension of the license without the necessity of any further administrative action until such time as the penalty is paid in full.

6. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.
