





COMPROMISE AND SETTLEMENT AGREEMENT

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter "the Division") and V & S Entertainment, LLC d/b/a Sweets Again, ("Sweets Again"), VGL # 2600112780, do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued Notices of Administrative Action to V & S Entertainment, LLC d/b/a Sweets Again, which notices allege certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notices of Recommendation of Administrative Action are set for hearing on January 25, 2007, before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the parties hereto are desirous of fully and finally compromising and settling all disputes and issues raised in connection with the said Notices of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. Pursuant to La. R.S. 27:311(K)(4), Sweets Again is required to submit annual forms and fees on or before July 1st of each year.

2. On October 23, 2006, and December 4, 2006, the Louisiana Gaming Control Board issued Notices of Recommendation of Administrative Action to V & S Entertainment, LLC d/b/a Sweets Again, VGL # 2600112780, alleging certain violations of Louisiana Gaming Control Law.

3. Sweets Again admits that it failed to timely submit the required annual forms and fees in 2005 and 2006, thereby violating the statute and regulations cited in the Notices of Recommendation of Administrative Action.

4. Sweets Again has since submitted the required forms and fees.

TERMS AND CONDITIONS

1. The Division reserves the right to take into consideration this violation in connection with any future violations.

2. Any and all information discovered throughout the course of this or any other investigation may be used in connection with any future violation(s), assessment of penalty or in any future determination of the suitability of Vanessa Grishaw or V & S Entertainment, LLC d/b/a Sweets Again .

3. Sweets Again agrees to pay a civil penalty of One Thousand Dollars (\$1000.00).

4. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and V & S Entertainment, LLC d/b/a Sweets Again, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

5. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not

thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits.

6. If approved, V & S Entertainment, LLC d/b/a Sweets Again must make payment of the civil penalty to the Division within ten (10) days of approval by the Louisiana Gaming Control Board. Failure to do so shall result in the immediate suspension of the license without the necessity of any further administrative action until such time as the penalty is paid in full.

7. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

I have read this entire Compromise Settlement Agreement, understand it, and agree to all stipulations and terms and conditions hereof.
