# JOINT MOTION FOR ENTRY OF STIPULATIONS AND APPROVAL OF PROPOSED SETTLEMENT

DEC | 3 2000

On Joint Motion of:

- (i) the Louisiana Department of Public Safety and Corrections, Office of State Police, Riverboat Gaming Division ("Division"), and
- (ii) Catfish Queen Partnership in Commendum Jazz Enterprises d/b/a Belle of Baton Rouge ("Licensee"), enter the following Stipulations into the record:

WHEREAS, on March 27, 2000 the Division caused to be sent to the Licensee a Notice of Violation and Penalty RGS 000159, SAR 00-1-03-107-1096. In that Notice, it was alleged that the Licensee violated LAC 42:XIII.2715(A)(1) and LAC 42:XIII.2723(J)(1)(2) and (5).

WHEREAS, the Notice assessed a \$5,000.00 penalty for violating LAC 42:XIII.2715(A)(1) and a \$10,000.00 penalty for violating LAC 42:XIII.2723(J)(5). The Licensee was warned as to its violation of LAC 42:XIII.2723(J)(1) and (2).

NOW, THEREFORE, in consideration of the foregoing Stipulations, the Division and Permittee hereby propose the following Settlement:

- 1. Licensee acknowledges its violation of LAC 42:XIII.2723(J)(5).
- 2. Licensee will pay a money penalty of \$10,000.00 for one violation of

#### LAC 42:XIII.2723(J)(5).

- 3. This settlement will act as a written warning as to the violation of LAC 42:XIII.2715(A)(1) contained in the Notice of Violation and Penalty RGS 000159, SAR 00-1-03-107-1096.
- 4. Subject to the approval of the Hearing Officer of the Louisiana Gaming Control Board, the Division and Licensec hereby agree to accept this Settlement as full and final settlement of the Notice of Violation and Penalty, RGS 000159, SAR 00-1-03-104-1096.
- 5. It is expressly understood that this proposed settlement, if approved by the Hearing Officer, is not executory and will be submitted to the Louisiana Gaming Control Board for its determination, as to whether the matter should be heard by the Hearing Officer. The parties hereby consent to this procedure.
- 6. The Division and Licensee waive their rights to appeal this Stipulation if the Order is signed by the Hearing Officer and is accepted by the Louisiana Gaming Control Board.
- 7. The Division reserves the right to take these violations into consideration in connection with any subsequent violations.
- 8. This Stipulation and Settlement is to be interpreted under the laws of the State of Louisiana.
- 9. This Stipulation and Settlement constitutes the entire Agreement between the Division and Licensee pertaining to the subject matter contained herein and supercedes all prior and contemporaneous agreements, representations, and understandings of the parties.
