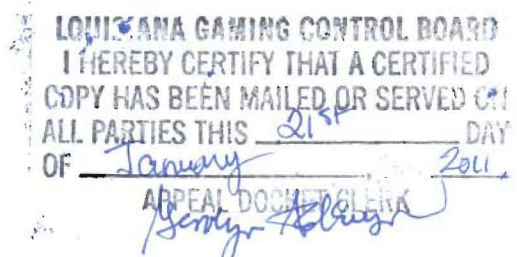

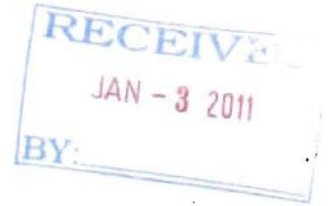

~~COMPROMISE AND SETTLEMENT AGREEMENT~~

The State of Louisiana, Department of Public Safety and Corrections, Office of State Police (hereinafter, the "Division") and Superstop Enterprises, Inc. d/b/a Square Deal Casino (hereinafter "Isle of Capri") do hereby represent and agree as follows:

WHEREAS, the Louisiana Gaming Control Board has issued a Notice of Recommendation of Administrative Action to Square Deal Casino alleging certain violations of Louisiana Gaming Control Law; and

WHEREAS, the issues raised by the said Notice of Recommendation of Administrative Action are set for hearing before the Louisiana Gaming Control Board Administrative Hearing Office; and

WHEREAS, the Division and Square Deal Casino are desirous of fully and finally compromising and settling all issues and disputes arising out of and in connection with the said Notice of Recommendation of Administrative Action;

NOW, THEREFORE, in consideration of the foregoing, the parties hereto do hereby agree and stipulate as follows:

STIPULATIONS

1. Square Deal Casino operates a truckstop facility located at 12091 Highway 70, Convent, La.

2. Square Deal Casino subleased the truck stop property from Robert Family Partnership #1, which leased the property from Donald Stein, Sr., Roland P. Stein, Roy J. Stein, and Harry F. Stein, Jr. Based on the terms of the lease agreement, the Division required the Steins to meet suitability.

3. On May 4, 2008, Donald Stein, Sr. passed away. Donald Stein, Sr.'s death was not reported to the Division until May 18, 2010, the date the Division received Square Deal Casino's 2010-2011 renewal application.

4. According to the Statutory Last Will and Testament, Donald Stein, Sr. left all of his right, title and interest in and to the truckstop property (25%) and the lease agreement (25%) between the Steins and Robert Partnership #1 to his spouse, Kathlyn Stein and his four children: Rhonda Barrillaux, Donald Stein Jr., Donna Bratcher, and Tanya Boudreaux.

5. The 25% interest in the truckstop property and the lease agreement were divided into five equal portions; resulting in each of his heirs receiving a 5% ownership interest in the truck stop property and the lease agreement. Kathlyn Stein previously met suitability as the spouse of the deceased, however, the other four heirs of the deceased participated in gaming for a period of over two years before submitting to a suitability investigation.

TERMS AND CONDITIONS

1. In lieu of Administrative Action of its Gaming License, Square Deal Casino will pay a civil penalty of TWO THOUSAND SEVEN HUNDRED FIFTY AND NO/100 (\$2,750.00) DOLLARS.

2. The Division hereby agrees to accept Square Deal Casino's payment of the above stated penalty in full and final settlement of the Notice of Recommendation of Administrative Action.


3. The Division reserves the right to take into consideration these admitted violations in connection with any future investigation, violation or assessment of penalty and in connection with any future assessments of Square Deal Casino's suitability.

4. The terms of this Compromise and Settlement Agreement shall be interpreted under the laws of the State of Louisiana.

5. This Compromise and Settlement Agreement constitutes the entire agreement between the Division and Square Deal Casino, pertaining to the subject matter contained herein and supersedes all prior and contemporaneous agreements, representations and understandings of the parties.

6. This Compromise and Settlement Agreement is subject to approval by the Hearing Officer and the Louisiana Gaming Control Board. It is expressly understood that if this proposed settlement is approved by the Hearing Officer, this agreement is not thereby executory, but will be submitted to the Louisiana Gaming Control Board for its determination as to whether to approve same or to remand the matter to the Hearing Officer for a full hearing on the merits. Failure to pay the penalty within fifteen (15) days of approval of this settlement by the Louisiana Gaming Control Board, and to comply with each term and condition listed herein, shall result in the immediate suspension of Square Deal Casino's license without the necessity of further administrative action, until such time as the penalty is paid in full.

I have read this entire Compromise Settlement Agreement and agree to all stipulations and terms and conditions hereof.


