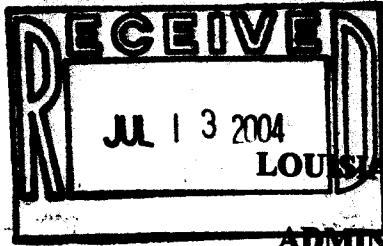

**JOINT MOTION FOR ENTRY OF STIPULATION AND APPROVAL OF  
PROPOSED SETTLEMENT**

On Joint Motion of:


- (i) the State of Louisiana, Office of State Police, ("Division"), and
- (ii) Hollywood Casino Shreveport acting herein on its own behalf and on behalf of Penn National Gaming, Inc., its parent and all of the subsidiaries of Penn National Gaming, Inc. ("Hollywood Casino").

who enter the following Stipulations into the record:

Whereas, a Notice of Violation and Penalty (the "Notice of Violation") was issued by the Division to Hollywood Casino on May 7, 2004 alleging that Hollywood Casino violated several casino gaming regulations because it did not notify the Division of a patron who cheated at Hollywood Casino;

And Whereas, Hollywood Casino desires to settle and agree to certain of the allegations contained in the Notice of Violation

NOW, THEREFORE, in consideration of the forgoing Stipulations, the Division and Hollywood Casino hereby propose the following settlement:


- (1) Hollywood Casino does admit to the violation of LAC 42:XIII.3311(B) in that under the circumstances, the Division should have been notified of the incident which is described in the Notice of Violation.
- (2) Hollywood Casino will pay a civil penalty of TEN THOUSAND DOLLARS (\$10,000.00).
- (3) In accordance with La. R.S. 27:57(C) and because of the current financial condition of Hollywood Casino and none of the alleged violations had any direct impact on state revenues, the Division hereby agrees to accept Hollywood Casino's payment of the above stated penalty in full and final settlement of CGD 040053.a.
- (4) The Division reserves the right to take into consideration these violations in connection with any future violation.
- (5) This Stipulation and Settlement is to be interpreted under the laws of the State of Louisiana.
- (6) This Stipulation and Settlement constitute the entire agreement between the Division and Hollywood Casino pertaining to the subject matter contained, herein, and supercedes all prior and contemporaneous agreements, representations, and understandings of the parties.
- (7) This Stipulation and Settlement is subject to approval by the Hearing Officer of the Louisiana Gaming Control Board. It is expressly understood that if these proposed Stipulations and Settlement are approved by the Hearing Officer, this agreement is not executory and will be submitted to the Louisiana Gaming Control Board for its determination as to whether the matter should


be heard by the Hearing Officer ; if approved, payment of the above penalty must be submitted within fifteen (15) days of this approval to the Louisiana Gaming Control Board

(8) Division and Hollywood Casino waive their rights to appeal this Stipulation and Settlement if the Order is signed by the Hearing Officer and accepted by the Louisiana Gaming Control Board.

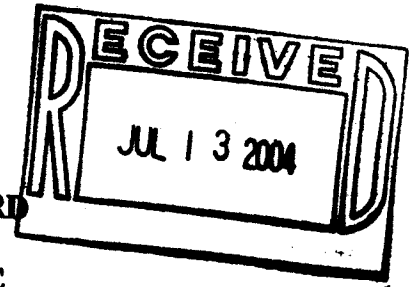

ORDER


CONSIDERING the foregoing Joint Motion and Stipulations,


